



The **Rose Hill Cemetery** is located on Rose Hill Road, approximately two miles north of Roseville. The **Roseville Cemetery** is located within the corporation limits of Roseville off of Zanesville Road.

Rose Hill Cemetery is a modern burial park with perpetual care and maintenance. **Roseville Cemetery** is an historical cemetery with perpetual care and maintenance furnished by the taxpayers of Roseville.

The Village Council has established a high standard of efficiency, as well as rules for the protections of the lot owners of every lot in Rose Hill and Roseville Cemetery. The following rules govern protections for lot owners, as well as enable the perpetual care and maintenance of the cemeteries.

Every lot sold by the Village is subject to the following conditions, restrictions and reservations, and each person who accepts a deed is bound by them:

1. Each and every lot shall be used solely for the purpose of burial of the remains of human beings; no lot shall be used for any other purpose.
2. The Cemetery Committee and Village employees shall have the right at all times to enter upon each and every lot for the purpose of maintaining, cleaning and policing the same.

3. No work of any character shall be done upon any lot except by the Village Council or some other person authorized on its behalf, and no lawns, trees, shrubbery, structures, improvements, enclosures, or excavations shall be placed or dug upon any lot except by written permission of Village Council.
4. No charges shall be made by the Village Council for any work done in caring for and maintaining in repair or replacement due to the elements of ordinary wear and tear, any of the trees, lawns, shrubbery, lots, graves, roads, drains, enclosures, improvements and structures upon any lot and in keeping the same clean and in good order, not including however, the repair or replacing of any gravestone or monumental structure erected upon any lot or any grave therein, nor the cost of any interment or disinterment of any body, nor any special or unusual work. Council may, upon recommendation of the Cemetery Committee, assess charges for the installation, repair, or replacement of any grave therein, or for any interment or disinterment of any body, or for constructing foundations for any monument, vault, mausoleum, or for any special or unusual work.
5. No trees, shrubs, or plants shall be planted upon or removed from any lot, or pruned, except with the consent of the Cemetery Committee, but the Village shall have the right from time-to-time to plant, transplant, remove or prune trees, shrubbery and plants upon said lots.
6. No improvement shall be made, or monument or structure erected and no object or inscription shall be used or placed in or upon any lot, except with the consent of the Cemetery Committee. In no instances shall a marker or

monument be erected on any lot or grave within the limits of said cemetery exceeding four (4) feet in height. The maximum length permitted for a single grave is 42 inches and depth of 18 inches. The maximum length permitted for a double grave is 84 inches and depth of 18 inches. Benches are permitted, as long as they are used as the headstone and have a footer. Footstones are permitted, as long as they are flush with the ground so as not to interfere with mowing and have a footer. No monument may encroach on someone else's lot.

7. No flowers or other ornaments or objects shall be kept upon lot after the same have become withered, soiled or unsightly. In the case of the failure of the owner of any lot to remove any such objects, the Cemetery Committee shall have the right to remove the same.
8. No cornerstones, foundations, aprons, baskets, glass, crockery, wire, metal or other kind of a receptacle for flowers are permitted, except such that are attached to the foundation or the monument/stone. Any such that are not attached to the foundation or monument may be removed by the Cemetery Committee. Shepherd's hooks may be placed next to the headstone but cannot exceed 4 feet in height.
9. No fence, coping, ditch, hedge, iron trellis, post, chain railing, step, boxing, border, basket sheds, toys, wire arches, watering pots, crockery, glassware of any kind, a vehicle of any character, glass case, covering or box containing artificial wreath, or enclosure of any kind, shall be placed upon any lot.
10. Temporary cross memorial markers will only be permitted as temporary markers

not as permanent headstones. Such markers must be removed during spring clean up and not be placed back on the grave(s).

11. No interment or disinterment shall be made upon any lot except upon written consent of the Village Council and of the owner of the lot.
12. No more than six cremations may be interred upon any lot and only one cremation may be interred on a lot containing a full burial vault.
13. The cemeteries shall not be entered by any person between the hours of sunset and seven o'clock a.m. without the consent of the Cemetery Committee.
14. Arrival time for funerals is set for 10am or later.
15. Any person visiting any lot shall respect the solemnity of the cemeteries, and no loud noises or disorderly conduct shall be permitted upon any road, walk, parkway or any portion of the cemeteries.
16. The grade of all lots, lawns and avenues as established by the Village Council shall not be altered or changed except by the Village Council.
17. No firearms, refreshments or intoxicating liquors shall at any time be brought upon any portion of the cemetery; provided, however, that the firearms may be used and discharged in case of a military funeral or by special permission of the Village Council.
18. The roadways and walks are the property of the Village of Roseville and are the only means to be used by any person entering or exiting the

cemeteries. The Cemetery is patrolled and violators will be prosecuted.

19. The term Cemetery Committee herein before used, refers to the three appointed members of Council of the Village of Roseville. The term "lot or lots" herein before used, refers to lot or lots and parcels shown in any plat or subdivision of the Rose Hill and Roseville Cemeteries.
